 - b. NDC audits will be done at time of ticketing to compare the ticketed fare to the fare offered on a carrier's website for the exact same flights/dates/cabin class and inventory

2. Cost Recovery Audits:

a. Under EU regulation <u>EU261/2004</u> passengers are entitled to up to €600 in compensation per person, depending on the flight distance and the duration of the

delay.

b. PaxFour has signed an exclusive agreement with PTC to be their USA partner to

secure cash compensation from airlines to corporate clients going back 3 years.

i. This auditing model can also be deployed for forward bookings as of January 1,

2025.
